No individual communication shall be sent to the candidates by Post. However, the Commission provides the

additional facility to the candidates intimating events relating to Certificate upload, etc., via SMS and e-mail through their registered Mobile Number and e-mail ID. The candidates are directed to watch the Commission's website, 'X' account, Telegram channel and WhatsApp channel periodically for all updates and intimations. The Commission shall not be responsible if the communication does not reach the applicant due to incorrect / invalid e-mail ID / mobile number and failure / delay in delivery of SMS / e-mail to the candidates due to any reason including technical issues. Any representation from the candidates for non-receipt of SMS or e-mail will receive no attention.

Note:

1. **Mere inclusion of the Register Number of candidates in this list will not imply that his/her candidature has been fully considered for the Main Written Examination.**
2. The candidates whose Register Number are found in the above list have been **admitted provisionally to the Main Written Examination** based on the marks obtained by them in the Preliminary Examination, claims made in the online application and with reference to the rule of reservation of appointments in the ratio of 1:10. However, in each reservation group, all the candidates who have secured the same marks as that of the cut-off marks of their respective reservation groups, have also been admitted provisionally to the Main Written Examination though the number of candidates exceed 1:10 ratio in the reservation group concerned with reference to para 5.4 of the Commission's Notification

No.05/2025, dated 01.04.2025.

The admission of the candidates to the Main Written Examination is provisional subject to the verification and acceptance of the claims as made in their online application with regard to Age, Educational Qualification, Communal Category, PSTM status, Physical Standards etc. Any discrepancy between the details as given in the online application and the documents submitted shall result in the summary rejection of candidature after due process and they will not be admitted to the next stage of selection. No supplemental list will be published in the place of rejected candidates.
4. The candidates who have appeared for the Preliminary Examination and whose Register Number is not found in the above list, have not been admitted to the said Main Written Examination. Individual communication in this regard will not be sent to those candidates.
5. The admission of candidates to the said Main Written Examination is purely provisional subject to the outcome of Writ Petitions and other cases relating to this recruitment, if any, pending before the Hon'ble High Court of Judicature at Madras or its Madurai Bench.
6. Candidates who have been admitted provisionally to the said Main Written Examination are hereby advised to upload the scanned copy of all the relevant documents without fail. Failure to upload even any one of the essential documents will result in non-admission to the next stage of selection.
